2. Temporary electrical power is intended for completion of the construction process and testing equipment installed within the structure.
3. **Issuing approval for temporary power connection does not constitute approval to occupy the structure. A Certificate of Occupancy must be issued by the City of Tybee Island prior to any occupancy.**
4. The owner and contractor are hereby held responsible for any violations of this policy. A violation of this policy may result in disconnection of the electrical service until all violations and deficiencies are corrected.
